## 1. Definitions:

   (a) "addressable system" means an electronic device or more than one electronic devices put in an integrated system through which signals of television channels can be sent in encrypted form, which can be decoded by the device or devices at the premises of the subscriber within limits of the authorization made, through the Conditiona Access System and Subscriber Management System on the explicit choice and request of such subscriber, by the cable operator to the subscriber.
   (b) "attentive tarff package" (AFP) means a tarff package which a service provider may offer, in addition to the standard tarff package, for supply of a set box to the subscriber for receiving programmes;
   (c) "Authority" means Telecom Regulatory Authority of India established under sub-section (1) of section 3 of the Telecom Regulatory Authority of India setablished under sub-section (1) of section 3 of the Telecom Regulatory Authority of 1 ndia setablished under sub-section (1) of section 3 of the Telecom Regulatory Authority of 7 of 1995);
